**EMERGENCY POWERS ACT**

(Cap. 11)

**EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 13) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 13) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-Citizens who may enter Solomon Islands**

Each person specified in the Schedule, may enter Solomon Islands, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*, despite the prohibition under regulation 7(1) of the Regulations.

**EMERGENCY POWERS ACT**  
(Cap. 11)

**EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**  
**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD) (NO. 2) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period) (No. 2) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from Quarantine Period**

- (1) Each of the person specified in the Schedule is exempted from being quarantined at a Quarantine Station for the Quarantine Period starting, when each of the person specified in the Schedule enter Solomon Islands on 4 February 2022.
- (2) The exemption under paragraph (1) is subject to the condition that each of the person specified in the Schedule is subject to the condition that, each person:
  - (a) maintain physical isolation from any other person; and
  - (b) must wear a face mask at all times.
