EMERGENCY POWERS ACT

(Cap. 11)

EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (REQUIREMENTS) (NO. 2) (AMEND-MENT) (NO. 2) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 15 of the *Emergency Powers (COVID-19)(No. 3)Regulations 2021* (Legal Notice No. 318 of 2021), and with reference to sections 36(a) and 65(2) of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Honiara Emergency Zone)(Requirements)(No. 2)(Amendment)(No. 2)Order 2022.*

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Amendment to Legal Notice No. 19 of 2022

This Order amends the Emergency Powers (COVID-19) (Honiara Emergency Zone) (Requirements) (No. 2) (Amendment) (No. 2) Order 2022 (Legal Notice No. 19 of 2022) ("**Principal Order**").

4 Amendment to Paragraph 6

The Principal Order is amended by deleting paragraph 6 and substituting the following:

- "(1) A person in the emergency zone may be at a public place in the emergency zone if there are not more than 10 persons at the public place.
- (2) All churches in the emergency zone must be close.
- (3) In the emergency zone, all bars, night clubs, kai bars, kava bars, fast food bars, food court eating outlets, cafes and parts of premises accessed by the public to be served and to consume food or alcoholic beverages on the premises, must be closed, and remain closed, and no food or drinks may be served or consumed by members of the public on those premises.
- (4) However, a restaurant or bar in the emergency zone that is part of a hotel may serve guests accommodated at the hotel, and those quests may be served and

consume food or drink at the restaurant or bar if they:

- (a) sanitise their hands at the entrance of the restaurant or bar; and
- (b) enter, move about and leave the restaurant or bar wearing a face mask (but may remove it while seated at the restaurant or bar."
