#### REVOCATION

## CUSTOMS AND EXCISE (EXPORT DUTY RATES FOR ROUND LOGS) (FIRST QUARTER) (AMENDMENT) ORDER 2022

I, Hon. Harry Degruit Kuma, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:

#### 1. Citation

This Order may be cited as the *Customs and Excise (Export Duty Rates for Round Logs) (First Quarter) (Amendment) Order 2022.* 

#### 2. Commencement

This Order commences the date of publication in the Gazette.

#### **3. Prohibited species**

This Order does not have the effect of allowing the export of species which are prohibited for export as round logs under the *Forest Resources and Timber Utilization Act* (Cap. 40) or any other Act.

### 4. Export duty listed in Schedule

The export duty payable on the export of round logs shall be calculated and determined according to the Schedule to this Order.

#### 5. Amendment of First Schedule

The First Schedule to the *Customs and Excise Act* (Cap. 121), is amended in tariff item number **44.03**, by replacing the rates of the previous Order with the rates in the Schedule to this Order.
