**HONIARA CITY (SALARIES AND ALLOWANCES OF MEMBERS OF
THE CITY COUNCIL) ORDER 2022**

I Hon. Christopher Laore, Minister for Home Affairs, under section 15(1) of the *Honiara City Act*, the Minister for Home Affairs makes the following Order:

1 Citation

This Order may be cited as the *Honiara City (Salaries and Allowances of Members of the City Council) Order 2022*.

2 Commencement

The Order commences on the it is published in the *gazette*.

3 Local daily subsistence allowance

- (1) A member is entitled to a daily subsistence allowance set out in Schedule 1 to this Order when on local official visits to other provinces within Solomon Islands, subject to prior approval of the Council.
- (2) A member is entitled to an accommodation allowance when on local official visits provided that:
 - (a) the accommodation allowance covers the reasonable costs of accommodation only and shall not include Incidentals such as alcohol or other beverages or cigarettes; and

- (b) the Council will only meet costs that are supported by a quotation or invoice of the total cost for accommodation, and such documentation must be submitted prior to the visit, for the Council's approval before payment is made.

4 Overseas daily subsistence allowance

- (1) Subject to subsection (2), a member is entitled to a daily subsistence allowance set out in Schedule 1 of this Order for official overseas visits which includes attending seminars, conference, workshops, or work- related training.
- (2) If the seminar, conference, workshop or work- related training is funded by an overseas Government or organisation, the member is entitled to on-fifth of the full allowance set out in the Schedule.

5 Schedule

The following salaries and allowances in Schedule 1 and Schedule 2 must be paid to the members of the City Council.

6 Revocation

This Order revokes the *Honiara City Council (Members' Allowances) Order 2014* (Legal Notice No. 63 of 2014).
