PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 2) ORDER 2022

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the *Price Control (Application to Goods and Restrictions of Prices) (Amendment)(No. 2) Order 2022.*
- 2. This Order commences on 1 March 2022.
- 3. The *Price Control (Application to Goods and Restriction of Prices) Order* 1987 (Legal Notice. 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 12 (Liquid Petroleum Gas) and substituting:
