**EMERGENCY POWERS ACT**

(Cap. 11)

**EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021****EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO  
SOLOMON ISLANDS) (NO. 21) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 21) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-Citizens who may enter Solomon Islands**

Each person specified in the Schedule may, on or about 4 March 2022, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.

**EMERGENCY POWERS ACT**

**EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**  
**EMERGENCY POWERS (COVID-19) (EXEMPTION FROM QUARANTINE**  
**PERIOD OR HOME QUARANTINE PERIOD) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period or Home Quarantine Period) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from quarantine period or home quarantine period**

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period or home quarantined for the home quarantine period when the person enters Solomon Islands on or about 4 March 2022:
  - (a) Anthony Cook;
  - (b) Simon Cowie;
  - (c) Ernest Gibson.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person (apart from an authorised officer); and
  - (b) wear a face mask; and
  - (c) wash his or her hands with soap frequently; and
  - (d) use hand sanitizer frequently.
