EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 24) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 24) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-Citizens who may enter Solomon Islands

Terplen Priono, may enter Solomon Islands, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*, despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS ACT

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (EXEMPTION FROM QUARANTINE PERIOD OR HOME QUARANTINE PERIOD) (NO. 3) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period or Home Quarantine Period) (No. 3) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine or home quarantine period

- (1) Terplen Priono is exempted from being quarantined at a quarantine station for the quarantine period or home quarantined for the home quarantine period when he enters Solomon Islands on or about 9 March 2022:
- (2) The exemption under paragraph (1) is subject to the condition that Terplen Priono while in the Solomon Islands must:
 - (a) maintain physical isolation from any other person; and
 - (b) must wear a face mask at all times; and
 - (c) return to the vessel FV Jin Jinn Yi No. 26 as soon as he is discharged from the National Referral Hospital.
