EMERGENCY POWERS (COVID-19) REGULATIONS 2022

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 35) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 35) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Steve Crosling may, on or about 1 April 2022, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) REGULATIONS 2022

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE
PERIOD)(NO. 7) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice 112 of 2022), make

the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 7) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each of the following persons is exempted from being quarantined for the quarantine period when they enter Solomon Islands on or about 1 April 2022:
 - (a) David Howard;
 - (b) Peter Tong;
 - (c) Ronny Schiebel;
 - (d) Steve Crosling.
- (2) Pravik Chand is exempted from being quarantined for the quarantine period when he enters Solomon Islands on or about 8 April 2022.
- (3) The exemptions under subparagraphs (1) and (2) are each subject to the condition that, while in Solomon Islands, each person exempted:
 - (a) must be accommodated alone in a hotel room in Honiara in a manner that complies with the Government's quarantine procedures; and
 - (b) may only leave the hotel room to:
 - (i) install a CT Scan machine at the National Referral Hospital or conduct associated quality assurance procedures; or
 - (ii) train staff to use the CT scan machine; and
 - (c) must move from the hotel room to the National Referral Hospital, and from the National Referral Hospital to the hotel, in accordance with the Government's quarantine procedures; and
 - (d) while away from the hotel room must:
 - (i) maintain physical isolation from any other person through social distancing; and
 - (ii) wear a face mask at all times; and
 - (iii) practise hand hygiene; and
 - (e) must:
 - (i) be tested for COVID-19 once on each of the second day and tenth day the person is in Solomon Islands by a PCR test, and must test non-infectious for each test;
 - (ii) be tested for COVID-19 once on each of the fourth day, sixth day

- and eighth day the person is in Solomon Islands by a RAT test, and must test negative for COVID-19 for each test; and
- (iii) if the person tests infectious or positive for COVID-19, be isolated and kept separate from other persons, and treated for COVID-19, in accordance with the Government's isolation procedures for COVID-19 infected persons or the Government's procedures for COVID-19 for treating infected persons in home quarantine (as the case requires); and
 - (f) must be transported from the International Airport to the hotel where they are accommodated, and from the hotel to the International Airport, in accordance with the Government's quarantine procedures.
