# **EMERGENCY POWERS (COVID-19) REGULATIONS 2022**

# EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 38) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

## 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 38) Order 2022.* 

## 2 Commencement

This Order commences on the day it is published in the *Gazette*.

# 3 Non-citizens who may enter Solomon Islands

Each of the following persons may, on or about 6 April 2022, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* despite the prohibition under regulation 7(1) of the Regulations:

- (a) Benjamin Lengkeek Gilmour;
- (b) Mathew Alan Craig:
- (c) Susan Jean Henry;
- (d) Kerry-Jane Battersby;
- (e) Cherie Joy Seymour.

# PERIOD )(NO. 8) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice 112 of 2022), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 8) Order 2022.* 

## 2 Commencement

This Order commences on the day it is published in the *Gazette*.

# 3 Exemption from quarantine period

- (1) Each of the following persons is exempted from being quarantined for the quarantine period when they enter Solomon Islands on or about 6 April 2022:
  - (a) Benjamin Lengkeek Gilmour;
  - (b) Mathew Alan Craig;
  - (c) Susan Jean Henry;
  - (d) Kerry-Jane Battersby;
  - (e) Cherie Joy Seymour.
- (2) The exemption under subparagraph (1) is subject to the condition that, while in Solomon Islands, each person exempted must:
  - (a) be accommodated at the Heritage Park Hotel in Honiara in a manner that complies with the Government's quarantine procedures; and
  - (b) at all times:
    - (i) practise hand hygiene; and
    - (ii) except when in the person's hotel room:
      - (A) maintain physical isolation from any other person through social distancing; and
      - (B) wear a face mask; and
  - (c) be transported from the International Airport to the Heritage Park Hotel, and from the hotel to the International Airport, in accordance with the Government's quarantine procedures.
