# PRICE CONTROL ACT

(Cap. 64)

### PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 4) ORDER 2022

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under section 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the Price Control (Application to Goods and Restriction of Prices)(Amendment) (No. 4) order 2022.
- 2. This Order commences on 1 April 2022.
- 3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:

### PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 5) ORDER 2021

- 2. This Order commences on 8 April 2022.
- 3. The Price Control (Application to Good and Restriction of Prices) Order 1987 (Legal Notice. 47 of 1987) is amended in Schedule 3 by revoking serial No. 12 (Liquid Petroleum Gas) and substituting:
