EMERGENCY POWERS (COVID-19) REGULATIONS 2022

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 45) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 45) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands on or about 22 April 2022 despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 11) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice 112 of 2022), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 11) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each person specified in the Schedule is exempted from being quarantined for the quarantine period when they enter Solomon Islands on or about 22 April 2022:
- (2) The exemption under subparagraph (1) is subject to the condition that, while in Solomon Islands, each person exempted must:
 - (a) subject to subparagraph (b), be accommodated in the Heritage Park Hotel in Honiara in a manner that complies with the Government's quarantine procedures; and
 - (b) remain in the person's hotel room unless, in conducting official business, it is necessary for the person to leave the room to attend a meeting; and
 - (c) at all times:
 - (i) practise hand hygiene; and
 - (ii) except when in the person's hotel room:
 - (A) maintain physical isolation from any other person through social distancing; and
 - (B) wear a face mask; and
 - (d) be transported from the International Airport to the Heritage Park Hotel, and from the Heritage Park Hotel to the International Airport, in

accordance with the Government's quarantine procedures.

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 12) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each person specified in the Schedule is exempted from being quarantined for the quarantine period when they enter Solomon Islands on or about 22 April 2022:
- (2) The exemption under subparagraph (1) is subject to the condition that, while in Solomon Islands, each person exempted must:

- (a) be accommodated in the Heritage Park Hotel in Honiara in a manner that complies with the Government's quarantine procedures; and
- (b) at all times:
 - (i) practise hand hygiene; and
 - (ii) except when in the person's hotel room:
 - (A) maintain physical isolation from any other person through social distancing; and
 - (B) wear a face mask; and
- (c) be transported from the International Airport to the Heritage Park Hotel, and from the Heritage Park Hotel to the International Airport, in accordance with the Government's quarantine procedures.
