**EMERGENCY POWERS (COVID-19) REGULATIONS 2022****EMERGENCY POWERS (COVID-19) (REVOCATION) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulations 16, 17 and 18 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), and with reference to sections 36(a) and 65(2) of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Emergency Zone) (Revocation) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Revocation**
