**CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF  
SERVICE) ACT  
(Cap. 84)**

**CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE)  
(CHIEF JUSTICE) (AMENDMENT) REGULATIONS 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under section 3 of the *Constitutional Offices (Terms and Conditions of Service) Act* (Cap. 84), make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (Chief Justice) (Amendment) Regulations 2022*.

**2 Commencement**

These Regulations commence on the day they are published in the *Gazette*.

**3 Amendment of Constitutional Offices (Terms and Conditions of Service)  
(Chief Justice) Regulations**

These Regulations amend the *Constitution Offices (Terms and Conditions of Service) (Chief Justice) Regulations 2015* (Legal Notice No. 72 of 2015) (“*Principal Regulations*”).

**4 Regulation 2 amended**

Regulation 2 of the Principal Regulations is amended by omitting the definition of “*child*” and substituting:

“ “*child*” means a child of the Chief Justice who is under the age of 21 years and is:

- (a) living with and financially dependent on the Chief Justice; or
- (b) living apart from the Chief Justice and attending a full time primary, secondary or tertiary educational course;”.

**5 New regulation 20A**

The Principal Regulations are amended by inserting after regulation 20:

**“20A Annual medical expenses allowance**

The Chief Justice is entitled to the annual medical expenses allowance specified in the Schedule.”.

**6 Regulation 21 amended**

Regulation 21 of the Principal Regulations is amended by inserting after subregulation (2):

- “(3) When the Chief Justice, his or her spouse or a child of the Chief Justice is receiving medical examination or treatment outside Solomon Islands, the Government must pay for each day he or she receives the medical examination or treatment:
  - (a) if the Chief Justice, spouse or child is accommodated in a hotel, the amount of the cost of the hotel room used by him or her; and
  - (b) if the Chief Justice, spouse or child is accompanied by a carer and the carer is accommodated separately in another hotel room, the amount of the cost of the hotel room used by the carer; and
  - (c) a daily allowance that is equal to 50% of the daily overseas travel allowance payable to the Chief Justice under regulation 15.”.

**7 New regulation 28A**

The Principal Regulations are amended by inserting after regulation 28:

**“28A Pension scheme**

At the end of the Chief Justice’s term of office, if the Chief Justice has completed at least 10 years of continuous service, the Chief Justice is entitled to an annual pension equal to 50% of the annual salary payable to him or her immediately before the day on which his or her term of office ends.”.

## 8 Schedule repealed and substituted

The Principal Regulations are amended by repealing the Schedule and substituting:

**CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) (DEPUTY CHIEF JUSTICE) (AMENDMENT) REGULATIONS 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under section 3 of the *Constitutional Offices (Terms and Conditions of Service) Act* (Cap. 84), make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (Deputy Chief Justice) (Amendment) Regulations 2022*.

**2 Commencement**

These Regulations commence on the day they are published in the *Gazette*.

**3 Amendment of Constitutional Offices (Terms and Conditions of Service) (Deputy Chief Justice) Regulations**

These Regulations amend the *Constitution Offices (Terms and Conditions of Service) (Deputy Chief Justice) Regulations 2015* (Legal Notice No. 73 of 2015) (“*Principal Regulations*”).

**4 Regulation 2 amended**

Regulation 2 of the *Principal Regulations* is amended by omitting the definition of “*child*” and substituting:

“ “*child*” means a child of the Deputy Chief Justice who is under the age of 21 years and is:

- (a) living with and financially dependent on the Deputy Chief Justice; or
- (b) living apart from the Deputy Chief Justice and attending a full time primary, secondary or tertiary educational course;”.

**5 New regulation 20A**

The *Principal Regulations* are amended by inserting after regulation 20:

**“20A Annual medical expenses allowance**

The Deputy Chief Justice is entitled to the annual medical expenses allowance

specified in the Schedule.”.

## 6 Regulation 21 amended

Regulation 21 of the Principal Regulations is amended by inserting after subregulation (2):

- “(3) When the Deputy Chief Justice, his or her spouse or a child of the Deputy Chief Justice is receiving medical examination or treatment outside Solomon Islands, for each day he or she receives the medical examination or treatment the Government must pay:
- (a) if the Deputy Chief Justice, spouse or child is accommodated in a hotel, the amount of the cost of the hotel room used by him or her; and
  - (b) if the Deputy Chief Justice, spouse or child is accompanied by a carer and the carer is accommodated separately in another hotel room, the amount of the cost of the hotel room used by the carer; and
  - (c) a daily allowance that is equal to 50% of the daily overseas travel allowance payable to the Deputy Chief Justice under regulation 15.”.

## 7 Schedule repealed and substituted

The Principal Regulations are amended by repealing the Schedule and substituting:

**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (Puisne Judge) (Amendment) Regulations 2022*.

**2 Commencement**

These Regulations commence on the day they are published in the *Gazette*.

**3 Amendment of Constitutional Offices (Terms and Conditions of Service)  
(Puisne Judges) Regulations**

These Regulations amend the *Constitution Offices (Terms and Conditions of Service) (Puisne Judges) Regulations 2015* (Legal Notice No. 74 of 2015) (“*Principal Regulations*”).



**4 Regulation 2 amended**

Regulation 2 of the Principal Regulations is amended by omitting the definition of “*child*” and substituting:

“ “*child*” means a child of a Puisne Judge who is under the age of 21 years and is:

- (a) living with and financially dependent on the Puisne Judge; or
- (b) living apart from the Puisne Judge and attending a full time primary, secondary or tertiary educational course;”.

**5 New regulation 20A**

The Principal Regulations are amended by inserting after regulation 20:

**“20A Annual medical expenses allowance**

A Puisne Judge is entitled to the annual medical expenses allowance specified in the Schedule.”.

**6 Regulation 21 amended**

Regulation 21 of the Principal Regulations is amended by inserting after subregulation (2):

- “(3) When a Puisne Judge, his or her spouse or a child of the Puisne Judge is receiving medical examination or treatment outside Solomon Islands, for each day he or she receives the medical examination or treatment the Government must pay:
- (a) if the Puisne Judge, spouse or child is accommodated in a hotel, the amount of the cost of the hotel room used by him or her; and
  - (b) if the Puisne Judge, spouse or child is accompanied by a carer and the carer is accommodated separately in another hotel room, the amount of the cost of the hotel room used by the carer; and
  - (c) a daily allowance that is equal to 50% of the daily overseas travel allowance payable to the Puisne Judge under regulation 15.”.

**7 Schedule repealed and substituted**
