**EMERGENCY POWERS ACT**  
(Cap. 11)

**EMERGENCY POWERS (COVID-19) REGULATIONS 2022**  
**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO**  
**SOLOMON ISLANDS) (NO. 69) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 69) Order 2022*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition, each person specified in Schedule 2 may enter Solomon Islands under regulation 7(4) of the Regulations.

**4 Expiry**

This Order expires on 2 December 2022.
