EMERGENCY POWERS (COVID-19) REGULATIONS 2022**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 72) ORDER 2022**

I, Hon. Manasseh Maelanga, Deputy Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 72) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each of the following persons may enter Solomon Islands on or about 17 June 2022 despite the prohibition under regulation 7(1) of the Regulations:

- (a) Inbasekar Sundaramurthi;
- (b) Ashok Kumar;
- (c) Akshay Kumar Meena.

EMERGENCY POWERS ACT

(Cap. 11)

EMERGENCY POWERS (COVID-19) REGULATIONS 2022**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 20) ORDER 2022**

I, Hon. Manasseh Maelanga, Deputy Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice 112 of 2022), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 20) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

Each of the following persons is exempted from being quarantined for the quarantine period when they enter Solomon Islands on or about 17 June 2022:

- (a) Inbasekar Sundaramurthi;
- (b) Ashok Kumar;
- (c) Akshay Kumar Meena.

4 Condition of exemption

The exemption under paragraph 3 is subject to the condition that each person exempted must:

- (a) at all times:
 - (i) subject to subparagraph (ii), be accommodated in the Heritage Park Hotel in Honiara in a manner that complies with the Government's quarantine procedures; and
 - (ii) remain in the person's hotel room unless it is necessary for the person to leave the room to conduct official business; and
 - (iii) practise hand hygiene; and
 - (iv) except when in the person's hotel room:
 - (A) maintain physical isolation from any other person through social distancing; and
 - (B) wear a face mask; and
- (b) on the second day after entering Solomon Islands, be tested at the Central Field Hospital in Honiara for the presence of COVID-19 by a PCR test, and test non-infectious for COVID-19 for the test; and
- (c) be transported from the International Airport to the Heritage Park Hotel, and from the hotel to the Airport, in accordance with the Government's quarantine procedures.
