**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (Chief Justice) (Amendment) (No. 2) Regulations 2022*.

**2 Commencement**

These Regulations commence on the day they are published in the *Gazette*.

**3 Amendment of Constitutional Offices (Terms and Conditions of Service)

These Regulations amend the *Constitution Offices (Terms and Conditions of Service) (Chief Justice) Regulations 2015* (Legal Notice No. 72 of 2015) (“*Principal Regulations*”).
