**SOLOMON ISLANDS MARITIME AUTHORITY ACT  
(No. 9 OF 2018)**

**SOLOMON ISLANDS MARITIME AUTHORITY (MODIFICATION OF  
EXISTING REGULATIONS) MARITIME ORDER 2022**

The Solomon Islands Maritime Authority, under sections 66 and 68(3) of *Solomon Islands Maritime Authority Act 2018*, makes the following maritime order:

**1 Citation**

This Maritime Order may be cited as the *Solomon Islands Maritime Authority (Modification of Existing Regulations) Maritime Order 2022*.

**2 Commencement**

This Maritime Order commences on the day it is published in the *Gazette*.

**3 Meaning of existing regulation**

In this Maritime Order:

“*existing regulation*” means a provision of any of the following Regulations:

- (a) the *Shipping (Non-Convention Vessel Safety) Regulations 2006* (Legal Notice 208 of 2007);
- (b) the *Shipping (Pilotage Certification) Regulations 2010* (Legal Notice 66 of 2010);
- (c) the *Maritime Safety Administration (Research Vessels) Regulations 2010* (Legal Notice 67 of 2010);
- (d) the *Shipping (Marine Navigation Aids) Regulations 2010* (Legal Notice

- 68 of 2010);
- (e) the *Shipping (Registration) Regulations 2010* (Legal Notice No. 69 of 2010);
  - (f) the *Shipping (STCW Convention) Regulations 2010* (Legal Notice 147 of 2010);
  - (g) the *Shipping (Dangerous goods and IMDG Code) Regulations 2011* (Legal Notice No. 66 of 2011);
  - (h) the *Shipping (Marine Pollution) Regulations 2011* (Legal Notice No. 67 of 2011);
  - (i) the *Maritime Safety Administration (Ship and Port Security) Regulations 2011* (Legal Notice 68 of 2011);
  - (j) the *Shipping (Marine Inquiries and Investigations) Regulations 2011* (Legal Notice No. 69 of 2011).

**Note to paragraph 3:**

*In this Maritime Order:*

- (a) *in accordance with section 63(3) of the Interpretation and General Provisions Act (Cap. 85), a reference to “the Act” is a reference to the Solomon Islands Maritime Authority Act 2018; and*
- (b) *in accordance with section 63(4) of the Interpretation and General Provisions Act (Cap. 85), except where the context otherwise requires, words and expressions used in this Maritime Order have the same meaning as they have in the Act.*

#### 4 **Modification of existing regulations**

The provision specified in Column 2 of the table in the Schedule of the Regulations specified in column 1 is amended as described in column 3, in the same row.

---

**Note to paragraph 4:**

*Under section 68 of the Act:*

- (a) *existing regulations in force under the Maritime Safety Administration Act 2009 or the Shipping Act 1998 immediately before the commencement of the Act are on and from the commencement of the Act taken to be a maritime order made under section 66 of the Act; and*
- (b) *SIMA may, by maritime order, modify or repeal the existing regulations.*
