#### **EMERGENCY POWERS (COVID-19) REGULATIONS 2022**

# EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 78) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers* (COVID-19)(Exception for Entry into Solomon Islands)(No. 78) Order 2022.

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### 3 Non-citizen who may enter Solomon Islands

Indra Hermanwan may enter Solomon Islands on or about 26 June 2022 despite the prohibition under regulation 7(1) of the Regulations.

## **EMERGENCY POWERS (COVID-19) REGULATIONS 2022**

## EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD )(NO. 23) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice 112 of 2022), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers* (COVID-19)(Exemption from Quarantine Period)(No. 23) Order 2022.

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### **3** Exemption from quarantine period

- (1) Indra Hermanwan is exempted from being quarantined for the quarantine period when he enters Solomon Islands on or about 26 June 2022 for medical examination and treatment.
- (2) The exemption under subparagraph (1) is subject to the condition that, while in Solomon Islands, Indra Hermanwan must:
  - (a) be accommodated in Gizo, at Gizo Hospital, in accordance with the Government's quarantine procedures; and
  - (b) at all times:
    - (i) practise hand hygiene; and
    - (ii) maintain physical isolation from any other person through social distancing; and
    - (iii) wear a face mask; and
  - (c) be transported from the NFD licensed longline fishing vessel Yi Man to Gizo Hospital, and from Gizo Hospital to the longline fishing vessel, in accordance with the Government's quarantine procedures.
