#### LAW REFORM COMMISSION ACT

(Cap. 15)

#### APPOINTMENT OF COMMISSIONER

I, Hon. Clezy Rare, Minister for Justice and Legal Affairs:

- (a) under sections 3(2)(b) and (3) and 4(2) of the *Law Reform Commission Act* (Cap. 15), appoint Katena Tim Tarakabu to be a Commissioner on a part-time basis for four years, being a person who appears to me to have knowledge and interest in social welfare and religious affairs; and
- (b) for section 4(4) of the *Law Reform Commission Act* (Cap. 15), specify that the following salary and allowances are payable to the Commissioner:
  - (i) if the Commissioner attends a meeting, workshop, conference or seminar to carry out duties for performing the Commission's functions, a sitting allowance of \$1,000.00 for each day or part of a day that the Commissioner attends the meeting, workshop, conference or seminar;
  - (ii) if the Commissioner travels outside of Honiara to another area in Solomon Islands to carry out duties for performing the Commission's functions, a subsistence allowance of \$200.00 for each day or part of a day that the Commissioner is outside of Honiara;
  - (iii) except if the Commissioner's appointment is terminated for misconduct or because the Commissioner has been convicted of a criminal offence:
    - (A) an amount payable in a lump sum at the end of the Commissioner's term of office of \$15,000 for four years; or

- (B) if the Commissioner holds office for less than four years, the amount payable in a lump sum when the Commissioner ceases to hold office equivalent to the sum of \$3,750 for each year the Commissioner held office.

**LUDO COMPETITION REGULATIONS 2022**

In exercise of the powers conferred by section [6] of the *[Gaming and Lotteries] (Amendment) Act 2004*, the Minister for Home Affairs makes the following Regulations:

**Part 1 Preliminary matters****1 Citation**

These Regulations may be cited as the *Ludo Competition Regulations 2022*.

**2 Commencement**

These Regulations commence on date published in the *Gazette Notice*.

**3 Definitions**

In these Regulations:

“*ludo games*” means ludo competition conducted in an approved premise by a commercial gaming permit holder within Honiara City.

**Part 2 Administration****4 Application to conduct Ludo competition**

- (1) A holder of a commercial gaming permit may apply to the Board to conduct

a ludo competition in an approved premise.

- (2) An application to conduct a Ludo competition shall be made to the Board.

**5 Inspections of premises**

The Board upon receipt of the application prior to approval may request the applicant for inspection of its premises or venues to conduct the ludo competition.

**6 Approvals to conduct ludo competition**

The Board, upon receipt of the application and being satisfied, may approve the application and inform the holder of the commercial gaming permit thereafter.

**7 Board to impose terms and conditions**

The Board may impose terms and conditions on the commercial gaming permit holder before commencing or conducting the ludo competition within its approved premises.

**8 Minister's Declaration of approval of the premises and nomination of the game**

- (1) If the Board is satisfied with the premises for conducting the ludo competition as stated in the application, the Board shall advise the Minister to declare such premises as an approved premise as required under the principal regulations.
- (2) The Minister shall then nominate Ludo as a nominated game to be played within that approved premises.
