REGISTRATION PERIOD AND REGISTRATION CENTRES

The Electoral Commission:

- (1) under section 31 (1) of the *Electoral Act 2018*, sets the period for the registration of electors for Western Province and Choiseul Province to be from 2 August 2022 to 21 August 2022; and
- (2) under section 31 (3) of the Act, declare the following places under the column entitled “Registration Centers” in the Schedule, to be registration centres where electors can register in person during the registration period; and
- (3) under section 31(4) of the Act, declares the following places outside a constituency to be registration centres, where electors can register in person:
 - (a) Choiseul Province - Taro Provincial Centre;
 - (b) Western Province - Gizo Provincial Centre.
