**IMMIGRATION ACT 2012**

(Act No. 3 of 2012)

**REDUCTION OF RESTRICTION PERIOD**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industry, Labour and Immigration:

- (a) under section 42(3) of the *Immigration Act 2012*, with reference to section 42(3)(a),(c) and (d), reduce the restriction period that applies to FOO SOON THIAM; and
- (b) under section 42(4) of the Act, specify that the day on which the restriction period applying to Foo Soon Thiam ends is the day on which this notice is published in the *Gazette*.

**PRICE CONTROL ACT**

(Cap. 64)

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 13) ORDER 2022**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the *Price Control (Application to Goods and Restriction of Prices)(Amendment) (No. 13) Order 2022*.
2. This Order commences on 19 August 2022.
3. The *Price Control (Application to Goods and Restriction of Prices) Order 1987* (Legal Notice. 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 12 (Liquid Petroleum Gas) and substituting:

**“12 LIQUID PETROLEUM GAS**
