**SOLOMON ISLANDS MARITIME AUTHORITY (FEES, CHARGES  
AND LEVIES) (AMENDMENT) MARITIME ORDER 2022**

The Solomon Islands Maritime Authority, under section 66 of the *Solomon Islands Maritime Authority Act 2018*, make the following Maritime Order:

**1 Citation**

This Maritime Order may be cited as the *Solomon Islands Maritime Authority (Fees, Charges and Levies) (Amendment) Maritime Order 2022*.
