(No. 8 of 2007)

#### DETERMINATION OF RANK OF ASSISTANT COMMISSIONER

Anthony Kamutulaka Veke, Minister for Police, National Security and Correctional Services, by order under section 10(2) of the *Correctional Services Act* 2007 (Act No. 8 of 2007), prescribe the rank of Assistant Commissioner, which rank is immediately below the rank of Deputy Commissioner.

#### **CORRECTION SERVICES ACT 2007**

(No. 8 of 2007)

#### **CORRECTIONAL SERVICES (AMENDMENT REGULATION 2022**

I, Hon, Anthony Kamutulaka Veke, Minister for Police, National Security and Correctional Services, under section 75 of the *Correctional Services Act 2007*, and with reference to section 36(a) and 65(2) of the *Interpretation and General Provision Act* (Cap. 85) make the following Regulation:

#### 1 Citation

These Regulation may be cited as the *Correctional Services (Amendment) Regulation 2022.* 

#### 2 Commencement

These Regulation commence on the date they are published in the *Gazette*.

# 3 Amendment of Correctional Services Regulations

These Regulations amend the *Correctional Services Regulations* (Legal Notice 28 of 2008 ("Principal Regulations").

# 4 New regulations 8A

The Principal Regulations are amended by inserting after regulation 8:

#### "8A Assistant Commissioners

- (1) An Assistance Commissioner works to support the Commissioner and Deputy Commissioners perform their functions, and in doing so is subject to the direction of a Deputy Commissioner.
- (2) The qualifications for holding a position of Assistant Commissioner are:
  - (a) a Bachelor of Arts degree in a related field or at least 5 years experience at a senior level of management in a correctional environment; and
  - (b) high personal professional and ethical standards, including ability to be confidential and impartial at all times; and
  - (c) very good oral and written communication; and
  - (d) high capability for the following:
    - (i) strategic planning, development and management in correctional environments, including for tier and hierarchy responsibilities;
    - (ii) management of administrative responsibilities;
    - (iii) performance management of subordinate staff;
    - (iv) leadership in crisis situations in correctional environments;
    - (v) delivering timely high level reports;
    - (vi) developing and maintaining effective relationships within and outside of the Correctional Service.
- (3) The positions with the rank of Assistant Commissioner are:
  - (a) Assistant Commissioner Corporate Support; and
  - (b) Assistant Commissioner Rehabilitation, Regeneration and Reintegration.
- (4) The duties of the Assistant Commissioner Corporate Support are as follows:

- (a) to assist the Commissioner and Deputy Commissioner Corporate Services;
- (b) manage, supervise, mentor and professionally develop staff under the Assistant Commissioner Corporate Support's command;
- (c) undertake financial and resource management of the Correctional Service;
- (d) undertake human resource and performance management the of Correctional Service;
- (e) direct review, change and implement of all legislative responsibilities of the Correctional Service;
- (f) develop and maintain effective relationships with community and external stakeholder groups;
- (g) duties as assigned by the Commissioner or Deputy Commissioner Corporate Services.
- (5) The duties of the Assistant Commissioner Rehabilitation, Regeneration and Reintegration are as follows:
  - (a) to assist the Commissioner and Deputy Commissioner Operations;
  - (b) manage, supervise, mentor and professionally develop staff under the Assistant Commissioner Rehabilitation, Regeneration and Reintegration's command;
  - (c) manage, facilitate and monitor the Correctional Service Rehabilitation, Regeneration and Reintegration Framework and program outputs and delivery;
  - (d) develop and maintain effective relationships with community and external stakeholder groups;

# 5 Regulation 25 amended

Regulation 25 of the Principal Regulation is amended:

- (a) by omitting "Officers shall be classified into the following ranks" and substituting "For the purpose of section 10(3) of the Act, the ranks by which correctional services officers are classified are as follows:"; and
- (b) by inserting after paragraph (d):
- "(da) Assistant Commissioner".
