EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 39) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 6(2) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 39) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

- (1) The following persons may enter Solomon Islands under regulation 6(2) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* despite the prohibition under regulation 6(1) of the Regulations:

- (1.1) Mark Purdie;
- (1.2) Stephen De Maria;
- (1.3) Michael Bentley;
- (1.4) Susan Henry;
- (1.5) Deborah Rasmussen;
- (1.6) Warren Michael.

EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD) (NO. 16) ORDER 2020

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 16) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 25 October 2020:
 - (a) Mark Purdie;
 - (b) Stephen De Maria;
 - (c) Michael Bentley;
 - (d) Susan Henry;
 - (e) Deborah Rasmussen;
 - (f) Warren Michael.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must, while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the

Government's quarantine procedures.
