PRICE CONTROL ACT

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 19) ORDER 2022

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the *Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 19) Order 2022.*
- 2. This Order commences on 9 December 2022.
- 3. The *Price Control (Application to Goods and Restriction of Prices) Order* 1987 (Legal Notice No. 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 12 (Liquid Petroleum Gas) and substituting:

"12 LIQUID PETROLEUM GAS

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 20) ORDER 2022

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1 This Order is the *Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 20) Order 2022.*
- 2 This Order commences on 9 December 2022.
- The Price Control (Application to Goods and Restriction of Prices) Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:
