**EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 78) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19) (No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 78) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each of the following persons may enter Solomon Islands on 16 March 2021 despite the prohibition under regulation 7(1) of the Regulations:

- (a) Paul John Robinson;
- (b) Claudia Louise Walding;
- (c) Glen Cyril Elliott Solly.

4. Amendment of Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 75) Order 2021 (Legal Notice No. 69 of 2021)

This Order amends the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 75) Order 2021* (Legal Notice No. 69 of 2021):

- (a) by omitting from paragraph (3) “and 16 March 2021”; and
- (b) by omitting paragraph 3(d), (e), (f) and (g).
