(Cap. 64)

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) ORDER 2023

IN exercise or powers conferred upon me by sections 4 and 6 of the Price Control Act, I make this Order-

1. This Order may be cited as the Price Control (Application to Goods and Restrictions of Prices) (Amendment) Order 2023 and shall be effective on the 1st of January 2023.
2. The Price Control (Application to Good and Restriction or Prices) Order 1987 (Legal Notice. 47 of 1987) is amended in schedule 3 by revoking serial No. 13 (Petroleum Products) and substituting the following-

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 3) ORDER 2023

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the Price Control (*Application to Goods and Restriction of Prices*)(Amendment) (No. 3) Order 2023.
2. This Order commences on 1st February 2023.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:
