PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) ORDER 2023

IN exercise or powers conferred upon me by sections 4 and 6 of the Price Control Act, I make this Order-

- This Order may be cited as the Price Control (Application to Goods and Restrictions of Prices) (Amendment) Order 2023 and shall be effective on the 1st of January 2023.
- The Price Control (Application to Good and Restriction or Prices) Order 1987 (Legal Notice. 47 of 1987) is amended in schedule 3 by revoking serial No. 13 (Petroleum Products) and substituting the following-

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 3) ORDER 2023
