PRICE CONTROL ACT
(Cap. 64)

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 4) ORDER 2023

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the *Price Control (Application to Goods and Restriction of Prices)(Amendment) (No. 4) Order 2023*.
2. This Order commences on 13th February 2023.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (LN 47 of 1987) is amended in Schedule 3 by revoking serial No. 12 (Liquid Petroleum Gas) and substituting:

“12 LIQUID PETROLEUM GAS

LIQUID PETROLEUM GAS
