- 2. Design and review all existing business processes of SIG ICT Services to identify their impact on cyber and information security.
- 3. Develop approval and reporting mechanisms for each ICT team on what relates to information and cybersecurity.
- 4. Identify gaps in cybersecurity processes across the network (operations & development) of SIG ICT Services and report on those.
- 5. Develop security business processes, health reports for the Director ICT and other relevant government ministries and agencies.
- 6. Develop and Measure Security compliance performance metrics for all teams.
- 7. Communicate the value of security operations to Ministry Accountable Officers, Senior Government Officials, and other non-government key stakeholders.
- 8. Work with ICT Management to review, establish and review a security compliance framework (e.g., NIST, ISO27001, IEC27032).
- 9. Undertake any other duties as reasonably or directed by the Responsible Officer or Supervisor.
