THE CONSTITUTION OF SOLOMON ISLANDS AMENDMENT TO THE STANDING ORDERS OF THE NATIONAL PARLIAMENT OF SOLOMON ISLANDS

(Section 62 of the Constitution)

In accordance with section 62 of the Constitution, the National Parliament hereby makes the following Order –

- 1. This Order may be cited as the 2011 Amendment to the Standing Orders of the National Parliament of Solomon Islands.
- 2. The Standing Orders of the National Parliament of Solomon Islands is hereby amended by inserting the following new order as Order 71C.

"71C ENVIRONMENTAL AND CONSERVATION COMMITTEE

There shall be a Standing Committee designated the Environmental and Conservation Committee whose functions shall be –

- (a) to examine and make recommendations to the Government on measures adopted or required to be adopted to meet the challenges posed by environmental changes;
- (b) to monitor and examine measures adopted by the relevant administrative authorities in implementing the objects of national and provincial environmental legislation; and
- (c) such other matters which may be relevant or conducive to meet Solomon Islands International obligations, including the adoption of carbon trading measures."

Passed by Resolution of Parliament on 19th day of December 2011.

In accordance with section 62 of the Constitution, the National Parliament hereby makes the following Order:-

- 1. The Order may be cited as the 2011 (No. 2) Amendment to the Standing Orders of the National Parliament of Solomon Islands.
- 2. The Standing Orders of the National Parliament of Solomon Islands is hereby amended by inserting the following as Order 71D.

"71D PARLIAMENT STANDING COMMITTEE FOR PUBLIC EXPENDITURE

There shall be a Standing Committee designated the Parliament Standing Committee for Public Expenditure whose functions shall be to:-

- (a) review budget expenditure;
- (b) assess whether expenditure performance match policy in line with the Appropriation Act;
- (c) undertake value for money assessment of the budget;
- (d) ascertain whether the public expenditure meets quality or not; and
- (e) make such observations or recommendations arising from the committee's deliberations."

Passed by Resolution of Parliament on nineteenth day of December, 2011.
