**PRICE CONTROL ACT**  
(Cap. 64)

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 5) ORDER 2023**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the *Price Control (Application to Goods and Restrictions of Prices) (Amendment) (No. 5) Order 2023*.
2. This Order commences 1 March 2023.
3. The Price Control (Application to Good and Restriction or Prices) Order 1987 (Legal Notice. 47 of 1987) is amended in schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:
