IMMIGRATION ACT 2012

(Act No. 3 of 2012)

IMMIGRATION (AMENDMENT) REGULATIONS 2023

I, Hon. Fredrick Kologeto, Minister for Commerce, Industry, Labour and Immigration, under section 93 of the Immigration Act 2012, make the following Regulations:

1 Citation

These Regulations may be cited as the *Immigration (Amendment) Regulations* 2023.

2 Commencement

These Regulations commence on the date published in the Gazette.

3 Amendment of Immigration Regulations

These Regulations amend the *Immigration Regulations 2013* (Legal Notice No. 110 of 2013) ("**Principal Regulations**").

4 Regulation 5C repealed

Regulation 5C of the Principal Regulations is repealed.

5 Regulation 5CA repealed

Regulation 5CA of the Principal Regulations is repealed.

PRICE CONTROL ACT

(Cap. 64)

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 9) ORDER 2023

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 9) Order 2023.
- 2 This Order commences on 1 May 2023.
- 3. The *Price Control (Application to Goods and Restriction of Prices)* Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:
