Dear Esteemed Colleagues,

Subject: NDS Review Consultations -Desktop Review Phase.

One of the key policy of the Democratic Coalition Government for Advancement (DCGA) is the implementation of the 20 year Solomon Islands National Development Strategy (NDS) 2016-2035.

The implementation of the strategy by all stakeholders is now over seven years since its launch in 2016. The Cabinet of Solomon Islands has mandated a review of the NDS, taking into account the implications of recent significant development stressors such as the Covid 19 global pandemic, the impacts of the war in Ukraine, the social unrests of late 2021 and recent earthquakes in 2022. The objective of the mandated NDS review is assess the extent to which the NDS has met its objectives, understand the gaps, challenges and lessons learnt during implementation and provide practical recommendations for improved implementation of the NDS in the future. We share as an annex to this memo the terms of reference for the NDS review.

MNPDC has been directed to lead the review, in close collaboration with all SIG government ministries and agencies. Whilst an official launch of the review process will take place in the coming days, preliminary work to contribute to the desktop/literature review phase will commence on Monday 8th May 2023. This desktop and information/data mining process would also include consultations with all line ministries to mine data and information. The schedule for the consultations is attached in annex 2 to this memo. Would appreciate the presence and support of your relevant officials in these consultations. The timeline and activity lineup for the NDS review process is also annexed for your further information.

We look forward to your usual collaboration for this important exercise.
