New Zealand Short Term Training Scholarships

Good Governance

Overview

The New Zealand Government's Manaaki New Zealand Scholarships Programme is pleased to offer a Good Governance Course for Pacific scholars, supported by New Zealand International Development Cooperation Programme.

This is an intensive short course designed for participants from the Pacific who are currently in middle and senior management positions in each of the course sectors.

The course will be held in Auckland, New Zealand and will run over a two-week period. The course will be delivered by the University of Auckland's Public Policy Institute.

While the course does not constitute a formal tertiary qualification it will provide scholars with unique insights into New Zealand approaches and best practice in each sectoral study area.

On completion each scholar will be awarded a completion certificate from the Manaaki New Zealand Scholarships Programme.

When?

Good Governance for participants from the Pacific will commence on **13 November 2023** and will complete on **24 November 2023**.

Who should attend?

This course is suitable for officials with at least 5 years work experience in the relevant course sector. Participants should have basic level computer literacy and numeracy.

To be eligible for a Manaaki New Zealand Scholarship, all the following statements must be true:

- From the date my application is submitted, I will have lived in my country of citizenship for the last two years or more.
- Exception for diplomatic corps and their family: A member of the diplomatic corps or a dependant of a member of the diplomatic corps, living outside their own country, can apply for a Scholarship.
- I am not a citizen or permanent resident of any of the following countries: New Zealand, Australia, Bahrain, Canada, any European Union country, Iceland, Israel, Japan, Kuwait, Norway, Oman, Qatar, Russia, Saudi Arabia, Singapore, South Korea, Switzerland, the United Arab Emirates, the United Kingdom, or the United States of America.
- Exceptions: People from the following countries and territories are eligible to apply:
 - Niue and Tokelau, even though they are New Zealand citizens.
 - French Pacific Territories, even though they are French citizens.
 - New Zealand-Samoan and Timor-Leste-Portuguese dual citizens.
- I will be at least 18 years old at the time I start the scholarship.
- I am not currently serving in the military.
- Within the last five years, I have not had a New Zealand Scholarship terminated.

Applicants must also acknowledge and agree that:

- They have received endorsement from my employer to attend this training programme.
- They expect to meet the academic entry requirements (including English language requirements) for my planned training programme.

Presenters

The course will deliver leading expertise from the University of Auckland, including the Public Policy Institute, the School of Population Health, and the Business School. Industry experts who are considered world-class authorities will also be invited to ensure the highest quality content.

- Critically assess the current regional context for human rights, jurisprudence, and the rule of law
- Understand and apply best practices concerning transparency, participation and gender inclusive policymaking and budgeting
- Ability to identify current practice in e-governance and service delivery, and combatting corruption
- Recognise and exercise your role as a national and regional leader in advocating for policy and law advancement and regional lesson-drawing
