TEMOTU PROVINCE ELECTORAL ARRANGEMENTS (ANUTA WARD)(AMENDMENT) ORDER 2023

I, Hon. Rollen Seleso, Minister for Provincial Government and Institutional Strengthening, under section 7(4) of the *Provincial Government Act 1997*, with the consent of the Cabinet and following consultation with the Temotu Provincial Assembly, make the following Order:

1 Citation

This Order may be cited as the *Temotu Province Electoral Arrangements* (Anuta Ward) (Amendment) Order 2023.

2 Commencement

This Order commences on the date it is published in the *Gazette*.

3 Amendment to Principal Order

This Order amends the Schedule to the *Temotu Province Electoral Arrangements Order 1996* (LN No. 77 of 1996) ("*Principal Order*").

4 Schedule Amended

The Schedule to the principal order is amended:

- (1) by deleting:
 - (a) "number 16. Tikopia" and its "Area of Ward"; and
 - (b) "number 17. Neo" and its "Area of ward"; and
- (2) replacing with the following:
