I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the *Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 16) Order 2023.*
- 2 This Order commences on and from 8 September 2023.
- 3. The *Price Control (Application to Goods and Restriction of Prices)* Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 12 (Liquid Petroleum Gas) and substituting:
