**CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE)  
ACT  
(Cap. 84)**

**THE CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) (CHAIRMAN LEADERSHIP CODE COMMISSION) (AMENDMENT)  
REGULATIONS 2024**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under section 3 of the *Constitutional Offices (Terms and Conditions of Service) Act* (Cap. 84), make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Constitutional Offices (Terms and Conditions of Service) (Leadership Code Commission) (Amendment) Regulations 2024*.

**2 Commencement**

These Regulations commence on the date of their publication in the *Gazette*.

**3 Amendment of the *Constitutional Offices (Terms and Conditions of***

**Service) (Chairman Leadership Code Commission) Regulations 2006**

These Regulations amend the *Constitutional Offices (Terms and Conditions of Service) (Chairman Leadership Code Commission) Regulations 2006* (LN No.3 of 2006) (**“Principal Regulations”**).

**4 Regulation 3 repealed and substituted**

Regulation 3 of the Principal Regulations is repealed and substituted with the following:

**“Salary**

3 The Chairman shall be paid a fortnightly taxable salary of \$8,000.00.”.

**5 Regulation 4 repealed and substituted**

Regulation 4 of the Principal Regulations is repealed and substituted with the following:

**“Housing**

4 The Chairman shall be provided with an official residence free of rent; and in the absence of a rent-free residence, the Chairman shall receive a housing allowance of \$12,000.00 per month.”.

**6 Regulation 6 repealed and substituted**

Regulation 6 of the Principal Regulations is repealed and substituted by the following:

**“Vehicle**

6 The Chairman:

- (a) shall be provided with one Government vehicle free of charge and a fuel allowance of \$2,000.00 per month; and
- (b) where the Government is unable to provide a vehicle, the Chairman is to be provided with a transport allowance of \$6,000.00 per fortnight; and
- (c) where at the end of the Chairman’s contract, the contract is not renewed, the Chairman is entitled to purchase the vehicle under paragraph (a) at a fair market price.”.

**7 Regulation 7 amended**

Regulation 7 of the Principal Regulations is amended by substituting the figure “US\$250.00” with “USD\$300.00”.

**8 Regulation 8 amended**

Regulation 8 of the Principal Regulations is amended by substituting the

figure “\$150.00” with “\$300.00”.

**9 Regulation 9 amended**

Regulation 9 of the Principal Regulations is amended by substituting the figure “\$1,300.00” with “\$4,000.00”.

**10 Regulation 10 amended**

Regulation 10 of the Principal Regulations is amended by substituting the figure “\$5,000.00” with “\$10,000.00”.

**11 Regulation 11 repealed and substituted**

Regulation 11 of the Principal Regulations is repealed and substituted with the following:

**“Gratuity**

- 11 The Chairman is entitled to a gratuity of 35% of the basic salary under regulation 3, payable at the end of every 12 months of service, or at the end of the term.”.

**12 New regulations inserted**

The Principal Regulations is amended by inserting immediately after regulation 11 the following:

**“Domestic staff**

- 12 The Chairman is entitled to one domestic employee whose wages are payable and shall be charged to public funds and paid for by the government.

**Compassionate leave**

- 13 The Chairman shall be entitled to one return trip per annum either by sea or air on compassionate leave.

**Class of travel (overseas)**

14. (1) The Chairman is entitled to travel business class for all official overseas travels.
- (2) The spouse of the Chairman is entitled to travel business class:
- (a) when accompanying the Chairman for official overseas travel; and
  - (b) when the spouse is officially required to perform an official role in the Chairman’s official program of travel; and
  - (c) where subregulations (2)(a) and (b) are met, the spouse is also entitled to claim subsistence allowance at half the rate payable

to the Chairman in regulation 7.

- (3) Where subregulations (2)(a) and (b) are not met, the Chairman and the spouse are responsible for the spouse's travels.

**Medical treatment**

- 15 If the Chairman is not covered by medical insurance, the Chairman shall be entitled to \$10,000.00 per annum for outpatient and general practice treatments; and where hospitalisation is required, the Chairman is entitled to be covered under a Government approved Health Care Scheme.

**Death during incumbency**

- 16 Where the Chairman dies whilst in office, the Government shall be responsible for all funeral expenses and all other incidental expenses.

**Entertainment**

- 17 The Chairman shall be entitled to an entertainment allowance of \$20,000.00 per annum.”.
