**BUSINESS NAMES ACT 2014**

(No. 13 of 2014)

**BUSINESS NAMES (AMENDMENT) REGULATIONS 2024**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, under section 41 of the *Business Names Act 2014*, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Business Names (Amendment) Regulations 2024*.

**2 Commencement**

These Regulations commence on the date these Regulations are published in the *Gazette*.

**3 Regulations amended**

These Regulations amend the *Business Names Regulations 2016* (“**Principal Regulation**”) (Legal Notice No. 63 of 2016).

**4 Schedule substituted**

The Principal Regulation is amended by substituting “SCHEDULE PRESCRIBED FEES” with the following:

**COMPANIES ACT 2009**

(No. 1 of 2009)

**COMPANIES (AMENDMENT) REGULATIONS 2024**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, under section 207 of the *Companies Act 2009*, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Companies (Amendment) Regulations 2024*.

**2 Commencement**

These Regulations commence on the date they are published in the *Gazette*.

**3 Regulations amended**

These Regulations amend the *Companies Regulations 2010* (“**Principal Regulations**”) (Legal Notice No. 51 of 2010).

**4 Repeal and replacement of Part 1, Schedule 2**

(No. 7 of 2005)

**FOREIGN INVESTMENT (AMENDMENT) REGULATIONS 2024**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, under section 36 of the *Foreign Investment Act 2005*, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Foreign Investment (Amendment) Regulations 2024*.

**2 Commencement**

These Regulations commence on the date these Regulations are published in the *Gazette*.

**3 Regulations amended**

This Regulation amends the *Foreign Investment Regulations 2006* (“**Principal Regulation**”) (Legal Notice No. 47 of 2006).

**4 Schedule 3 substituted**
