# PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT) (NO. 4) ORDER 2024

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the Price Control (Application to Goods and Restrictions of Prices)(Amendment) (No.4) Order 2024.
- 2 This Order commences on the date this Order is published in the *Gazette*.
- 3. The *Price Control (Application to Goods and Restriction of Prices) Order* 1987 (Legal Notice No. 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 12 (Liquid Petroleum Gas) and substituting the following:

- 3. The *Price Control (Application to Goods and Restriction of Prices)* Order 1987 (Legal Notice No. 47 of 1987) is amended in Schedule 3 by deleting the item for serial No.13 (Petroleum Products) and substituting the following:
