# THE ORDER OF SOLOMON ISLANDS (AMENDMENT) REGULATIONS 2024

IN EXERCISE of powers conferred by statute XX of the Royal Warrant instituting The Order of Solomon Islands 1981, I, SIR DAVID VUNAGI, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight of Grace of the Most Venerable Order of Saint John, Governor-General and Commander-in-Chief of Solomon Islands, do hereby make the following Regulations:

#### 1 Citation

These Regulations may be cited as *The Order of Solomon Islands (Amendment) Regulations 2024.* 

#### 2 Commencement

These Regulations commence on the date they are published in the *Gazette*.

#### 3 Amendment to The Order of Solomon Islands Regulations 1981

These Regulations amend *The Order of Solomon Islands Regulations 1981* ("*Principal Regulations*").

#### 4 Regulation 19 repealed and substituted

Regulation 19 of the Principal Regulations is repealed and substituted by the following:

"19. The rates for sitting allowances, gratuity payments and other allowances and entitlements of the members are as prescribed in the Schedule:

### PART A: Rate for Sitting Allowance

No.	Member	Rate
1	Chairman	\$1,800.00 per sitting
2	Representative of the Churches	\$1,500.00 per sitting
3	Representative of the Commercial Sector	\$1,500.00 per sitting
4	Social Worker	\$1,500.00 per sitting
5	Representative of the Public Service	\$1,500.00 per sitting

### PART B: Rate for Gratuity Payment

No.	Member	Rate
1	Chairman	\$20,000.00 per term
2	Representative of the Churches	\$20,000.00 per term
3	Representative of the Commercial Sector	\$20,000.00 per term
4	Social Worker	\$20,000.00 per term
5	Representative of the Public Service	\$20,000.00 per term

#### PART C: Rates for Other Allowances and Entitlements

No.	Allowances	Rate
1	Passage (sea fare or air fare) for a Provincial Based Member	Standard rates issued by service providers
2	Accommodation for a Provincial Based Member if accommodation is not provided.	\$1,000.00 per night.
3	Subsistence allowance for a Provincial Based Member	\$250.00 per day
4	Food	\$150.00 per meeting".
