1. INTRODUCTION

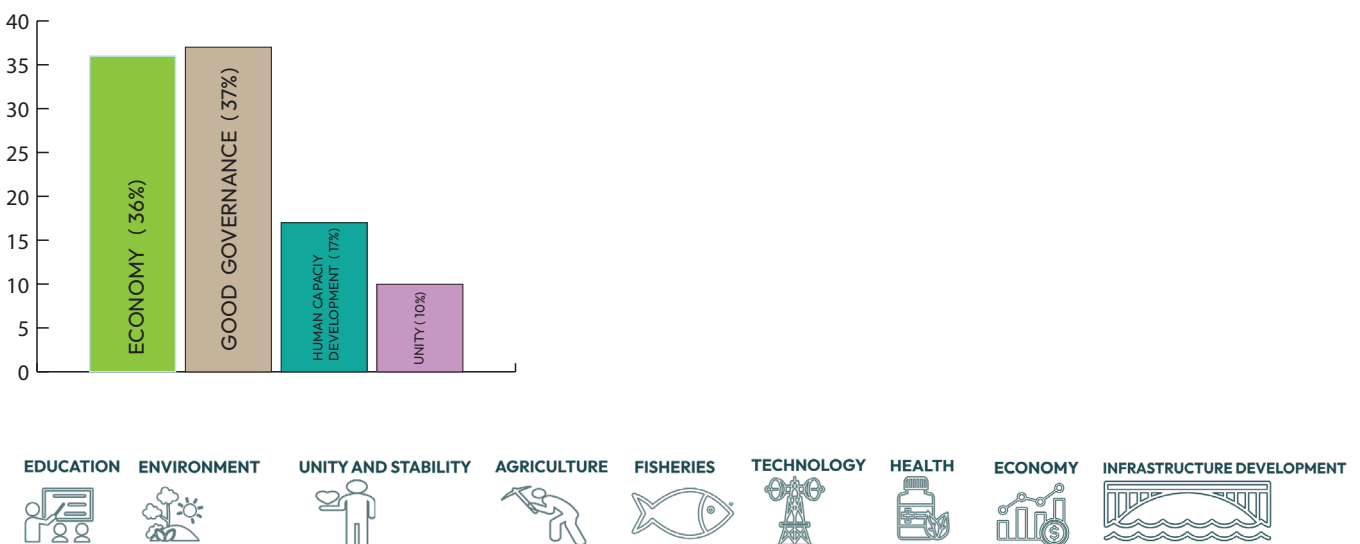
The Government for National Unity and Transformation (GNUT) is a coalition comprising of three political parties including i) OUR Party, ii) Solomon Islands People’s First Party and iii) Kadere Party. The GNUT was formed with the goal of uniting different political parties to work together towards the common good of the nation. Each party brings its own unique strengths and perspectives to the coalition, allowing for a more diverse and inclusive approach to governance. By coming together, the GNUT aims to address the various challenges facing the country and implement policies that benefit all citizens.

The 100-days program covers key areas that the GNUT prioritizes and seeks to address within its initial period in office. Each ministry has clear objectives and targets to meet in order to contribute to the overall plan. Economic recovery is the strategic focus of the GNUT, with plans to create jobs, attract investment, and stimulate growth in key sectors. With a united front, the GNUT is ready to tackle the obstacles ahead and bring about positive change for the people of the country. This 100-Days program is setting a solid foundation for long-term policy implementation. It is the commitment of the GNUT to work hand in hand with the people to overcome challenges and achieve positive change together.

The 100-days program is built upon four fundamental pillars: National Unity, Good Governance, Economic Recovery, and human capital development. These pillars are a direct reflection of the policy priorities outlined in the manifestos of the coalition partners. Additionally, to ensure continuity and effective implementation, the 100-days policy takes into account the ongoing policies of the previous DCGA government, with the active involvement of all 24 government ministries and Solomon Islands Chamber of Commerce and Industry.

The 100-days program is consequently pragmatic and heavily focused on practicality. Out of the 177 policy areas, 37% prioritize good governance to address longstanding gaps in legislation, which will require significant attention for reform in order to achieve economic transformation. Additionally, 36% of the policies target the economy, 17% focus on human capital development, and 10% are centered on National Unity (see Figure 1). Many of these policies address urgent issues in the health sector, infrastructure, social welfare, and the economy.

There is a policy provision for an economic summit, to be co-hosted by the Ministries of Planning, Commerce, and Finance to include all government, private, bilateral, and multilateral stakeholders. The outcomes of the summit are intended to guide and inform the formulation of substantive economic and infrastructure investment road map that is more targeted, ambitious and fundamentally transformational.

2. OBJECTIVE

The objective of this GNUT 100 Days program is to provide a set of strategic action for addressing key issues facing our community over the next 100-days. Through this programs, we aim to address diverse range of issues leading us to address our economic challenges. By focusing on key policy priority areas, we believe that we can make a positive impact on the lives of everyone across the country.

3. THE FOUR KEY PILLARS

These policy priorities are broadly encompassed under the following four key pillars including:

By aligning all efforts towards these key pillars, the government aims to create a conducive environment for businesses to thrive, attract foreign investment, and build a skilled workforce that can drive innovation and growth. With a clear roadmap laid out, stakeholders are motivated to work collaboratively towards a common goal of sustainable economic development. As progress is made in each of these areas, the country is poised to emerge stronger and more resilient in the face of future challenges.

It has eight broad objectives encompassing diverse thematic areas ranging from rural development to digital transformation. These objectives span infrastructure development and address socio-economic priorities. A dedication to national security, efficient governance, and strong frameworks to combat corruption. It is fortified by strong legislative reforms to enhance service delivery, strengthen compliance and improve the economic base. In short, it covers the government’s immediate actions and plans for stimulating economic growth, creating jobs, attracting investments, and addressing the country’s immediate financial challenges.



These include:

- a. Addressing social welfare and poverty through social assistance programs, rural sustainable development programs and other initiatives aimed at reducing poverty, addressing social inequality, and improving the overall well-being of vulnerable populations. Such approaches as the national cocoa and coconut rehabilitation strategy and commercial fisheries initiatives targeting rural populations will be supported.
- b. Healthcare Services and Public Health Priorities, related to improving healthcare infrastructures ensuring quality access and services, and resilient health response strategies to ongoing health challenges.
- c. Investing in human capital development through quality education and skills improvement strategies. By equipping individuals with the necessary knowledge and skills, they are better prepared to contribute to the economy and society as a whole.
- d. Infrastructure development to ensure that the growing population has access to essential services like clean water, electricity, and transportation. These include upgrading existing roads, bridges, and public transportation systems, as well as investing in new infrastructure projects to support economic growth and improve the quality of life for citizens.
- e. Ensure Environmental Sustainability to address ongoing environmental challenges, promote sustainable development practices, mitigate climate change impacts, and conservation of natural resources.
- f. Governance and Anti-Corruption Strategies promoting good governance, transparency, accountability, and rule of law, as well as initiatives to strengthen good governance institutions.
- g. Foreign Policy and Diplomacy Goals for continuous engagement with international community, fostering diplomatic relations, promoting trade and cooperation, and advancing national interests on the global stage.
- h. Digital Transformation and Innovation strategies for harnessing technology to drive economic growth, improve public service delivery, addressing accountability and transparency issues, restore trust on government and enhance public-government relationship.

These areas represent broad categories that GNUT prioritises in its early days in office.

4. PRIORITY PROGRAM INITIATIVES

To ensure GNUT implements its key strategic priorities, each sector has established clear objectives and performance indicators to track progress and measure the success of each policy statement. By setting clear purposes and performance indicators, GNUT can track progress and measure the success of each policy statement within its sectors within this first 100 Days. This proactive approach ensures that each sector effectively implements its key strategic priorities. With measurable outcomes in place, GNUT can make decisions to drive continuous improvement and achieve its overarching goals. By staying focused on its strategic priorities and adapting to changing circumstances, GNUT can achieve its mission and deliver meaningful impact in the communities it serves.

5. KEY SECTORS

There are four key sectors: fundamental, productive, resources, and social. Each sector will have specific goals and action plans to achieve within the 100-day timeframe. The fundamental sector focuses on improving governance and institutional capacity for the overall functioning of the economy. The productive sector aims to boost economic growth through investment in economic infrastructure, export orientated developments, and reform and restructure initiatives. The resources sector aim is to increase value-added industries, build a resilient economy, develop innovative development models, implement strategic development initiatives to maximize economic benefit, promoting economic growth. The role of the social sector is to ensure efficient delivery of essential services through effective and consistent delivery to support economic growth, essential services to function effectively, and bolstering support for economic stability and growth. By targeting these key sectors, the policy strategies aim to address the most pressing issues facing our country comprehensively and efficiently.

5.1 FUNDAMENTAL SECTOR

The fundamental sector consists of seven-line ministries, including the Office of the Prime Minister and Cabinet; Ministry of Foreign Affairs and External Trade; Ministry of Finance and Treasury; Ministry of National Planning and Development Coordination; Ministry of Justice and Legal Affairs; the Ministry of Traditional Governance, Peace, and Ecclesial Affairs; and the Ministry of Public Services. Each of these ministries plays a crucial role in ensuring the effective governance and development of the country. Together, these ministries form the backbone of the country's governance and development efforts, paving the way for a more prosperous and resilient future.

5.1.1 Office of the Prime Minister and Cabinet

- a. Finalize the implementation plan for the commencement of the Constituent Assembly;
- b. Finalise plans to initiate state infrastructure development projects;
- c. Initiate process to strengthen the function of Solomon Islands Independent Commission for Anti Corruption;
- d. Continue development of the National Laboratory policy (import and export products);
- e. Initiate Citizenship by Investment program;
- f. Buy back Levers Solomons Limited Estates;
- g. Complete the Audit Report on the Pacific Games 2023;
- h. Reactivate Transformation of Honiara Central Business District Project;
- i. Drive the implementation and monitoring of existing flagship programs and infrastructure projects through whole-of-government and whole-of-society approaches; and
- j. Progressive implementation of Electoral Reform.

5.1.2 Ministry of Foreign Affairs and External Trade

The productive sector consists of the following ministries: Ministry of Infrastructure Development; Ministry of Communication and Aviation; Ministry of Fisheries and Marine Resources; Ministry of Agriculture and Livestock; Ministry of Culture and Tourism; Ministry of Lands, Housing, and Survey; and Ministry of Commerce, Industry, Labour, and Trade. These ministries form a strong foundation for the country's economic growth.

The resource sector ministries include the Ministry of Rural Development, the Ministry of Mines, Energy Rural Electrification, the Ministry of Forestry and Research, and the Ministry of Environment, Climate Change, Disaster Management, and Meteorological Services. These ministries oversee the country's sustainable development and management of natural resources. They work to ensure the

responsible extraction of minerals, the promotion of renewable energy sources, the preservation of forests, and the protection of the environment from climate change and natural disasters. Through their combined efforts, they aim to support the country's economic growth while safeguarding its natural heritage for future generations.

The social sector line ministries promote efficient and effective delivery of essential services such as healthcare, education, national security, and social welfare. Through strategic partnerships and collaborations, the social sector line ministries can ensure that resources are allocated where they are most needed, ultimately improving the well-being of society as a whole and bolstering support for economic stability and growth.
