**HONIARA CITY COUNCIL (REGULATION OF BUSINESS LICENSES)
ORDINANCE 2011**

**CONDITIONS ON - LICENSEE BUS OPERATORS (LIABILITY OF BUS
DRIVERS AND BUS CONDUCTORS); AND OPERATION OF
BUSINESSES IN MORE THAN ONE LOCATION**

In exercise of the powers under section 4(1)(a) of the *Honiara City Council (Regulation of Business License) Ordinance 2011*, the Honiara City Council impose the following conditions:

1. All public buses shall display a destination sign at the front of the bus during the service hours.
2. All public buses shall completely serve the destination displayed at the front of the bus during the service hours.
3. That all public buses shall display their bus license at the front screen at all times.
4. The complete destinations refer to in subclause (2) are destinations shown in the destination sign from:
 - (a) Honiara Central Market to White River and from White River to Honiara Central Market;
 - (b) Honiara Central Market to KGVI and from KGVI to Honiara Central Market;
 - (c) Honiara Central Market to Borderline and from Borderline to Honiara Central Market;
 - (d) The bus fare for all destinations shall be three dollars for adults and two dollars for school children and children.
5. All Licensed Bus Operators must produce to the Council the names, driver's licence details, and contact details of the "Bus Drivers" and "Bus Conductors", engaged by the Licensed Bus Operators for the licensed operation.
6. A "Bus Driver" or "Bus Conductor" engaged by a Licensed Bus Operator who breaches the Licence Conditions (1), (2), (3) and (4), shall be liable as the licensee under section 8(1)(a)(b) of the *Honiara City Council (Regulation of Business License) Ordinance 2011*.

7. A business carried out in a specified location or premises, may not operate in a specified location or premises contrary to that specified in the licence.
8. A business operating in more than one location, must be licenced to operate in each location or premises as specified.
