PROTECTION OF WRECKS AND WAR RELICS ACT

(Cap. 150)

LICENCE TO CARRY OUT ACTIVITIES

I, Hon. Choylin Yim Douglas, Minister for Culture and Tourism, under section 4(2) of the *Protection of Wrecks and War Relics Act* (Cap. 150), grant this licence to Cpt Smith Jackson, Team Leader, Defence (Prisoners of War/Missing in Action) Accounting Agency (DPAA) Team ("the Licensee"), who appears to me to have a legitimate reason to carry out activities provided in section 4(1) of the Act, in the areas specified in Schedule 1 ("licensed area"), subject to the conditions and restrictions specified in Schedule 2 ("Conditions and Restrictions of Licence").

SCHEDULE 1 LICENSED AREAS

The points at sites in Guadalcanal Province and Western Province with the following Global Positioning System coordinates:

- (a) Guadalcanal Province -
 - (i) Near Gilbert Camp, 9° 27.205' South, 159° 59.353' East;
 - (ii) Niu Kolina 2, 9° 27.824' South, 160° 2.305' East;
 - (iii) Vuru Village, 9° 22.763' South, 159° 51.196' East; and
- (b) Western Province New Georgia near Noro IVO, 8° 13.938' South, 157° 12.122' East and near 8°11.505' South, 157° 16.244' East.

SCHEDULE 2

CONDITIONS AND RESTRICTIONS OF LICENCE

- 1. This licence is granted only for the purpose to conduct terrestrial and archaeological investigation, removal, and recovery of human remains of particular USA Servicemen and Women who died during WWII.
- 2. The licence is granted exclusively for the licensed areas and must not be used to carry out activities in any other restricted area.
- 3. This licence is valid from 8 July 2024 to 20 August 2024.
- 4. The Licensee is responsible for meeting the relevant costs of activities conducted under this licence including the recovery and transportation of human remains, the incidental hiring of local workers to assist in carrying

- out the activities under section 4(1) of the Act and the payment of fees to landowners before entering any customary area.
- 5. The Licensee must provide to Solomon Islands National Museum with an audit record or report of all information and results within the licensed area before exporting the remains out of Solomon Islands.
- 6. The Licensee must liaise with the Guadalcanal Provincial Government and the Western Provincial Government, and the WWII section of the Solomon Islands National Museum to ensure that WWII wrecks and relics within the licensed area are not removed or relocated.
- 7. The Licensee, if the licensed area comprises of customary land or part of customary land, whether or not the customary land or a part thereof includes foreshores or reefs, must ensure that customary protocols or courtesies relevant to customary land owners of that customary land must be complied with in good faith.
- 8. The Licensee must comply with relevant laws and ordinances in respect of the appropriate Province having jurisdiction over the licensed area and must liaise in good faith with the appropriate authority in the Provincial Executive.
- 9. The Licensee must at all times ensure that appropriate safety precautionary measures are followed to avoid loss of human life in carrying out activities under this license. If necessary, the Licensee is solely responsible for the engaging of the Explosive Unit of the Royal Solomon Islands Police Force to scan the licensed area for potential risks of poisonous gases and live ammunition from World War II unexploded devices.
- 10. The Licensee must ensure that no piece of World War II materials must be taken out of the country without approval granted by the Minister for Culture and Tourism
- 11. The licence immediately becomes null and void if the Licensee breaches any of the conditions and restrictions of this license or any provision of the *Protection of Wrecks and War Relics Act* (Cap. 150).
- 12. On the occurrence of any serious breach, the Licensee must forfeit all privileges and will not be issued a license for similar activities in the future.
