CIVIL AVIATION ACT 2008

(No. 7 of 2008)

**CIVIL AVIATION (ATTENDANCE ALLOWANCES AND EXPENSES)
REGULATIONS 2026**

I, Hon. Fredrick Kologeto, Minister for Communication and Aviation, under section 9, Part V and Schedule 1 of the *Civil Aviation Act 2008*, with reference to section 65 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Regulations:

1 Citation

These Regulations may be cited as the *Civil Aviation (Attendance Allowances and Expenses) Regulations 2026*.

2 Definitions

In these Regulations:

“**Act**” means the *Civil Aviation Act 2008* (No. 7 of 2008);

“**Authority**” means the Civil Aviation Authority of Solomon Islands established under section 9 of the Act.

3 Commencement

These Regulations commence on the date these Regulations are published in the Gazette.

4 Attendance allowance

A member of the Authority is entitled to the attendance allowance specified

in Table 1 of the Schedule.

5 Meetings held outside Solomon Islands

A member who attends a meeting of the Authority outside Solomon Islands is entitled to the attendance allowance specified in Table 1 of the Schedule, payable in the currency of the country where the meeting is held.

6 Travelling allowance

A member who travels outside Solomon Islands to attend a meeting, conference, seminar or other official business of the Authority is entitled to the travelling allowance specified in Table 2 of the Schedule.

7 Subsistence allowance

A member appointed under section 9(1)(c) of the Act is entitled to the subsistence allowance specified in Table 3 of the Schedule for each day the member is in Solomon Islands while performing the functions of the Authority.

8 Repeal

The *Civil Aviation (Attendance Allowance and Expenses) Regulations 2010* (Legal Notice No. 31 of 2010) is repealed.

2	Member (including an ex officio member)	USD280.00 per day

Item	Member	Subsistence Allowance
