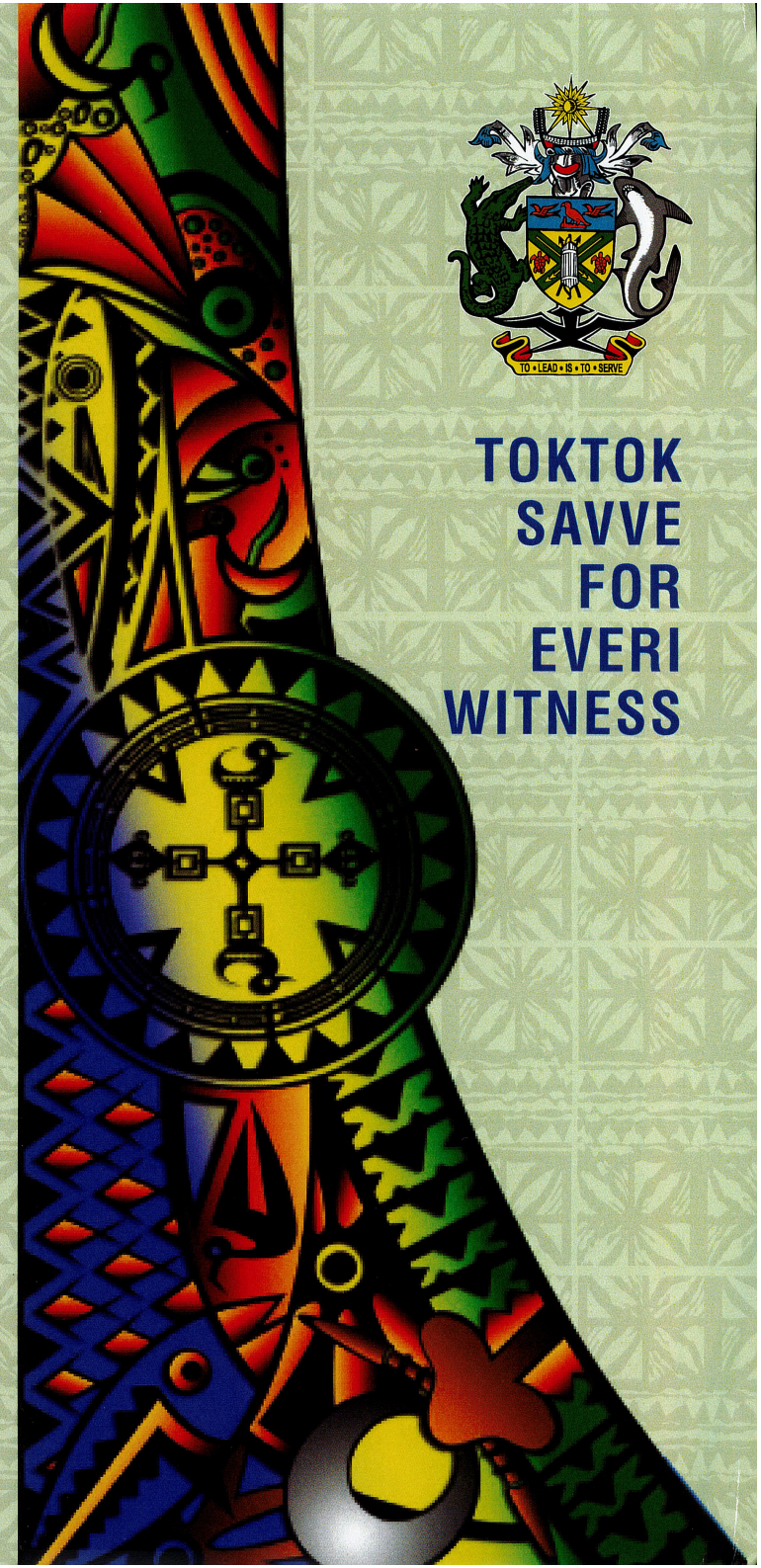

TOKTOK SAVE FO EVERI WITNESS

- Taem iu kam insaet long Kot, bae olketa givim iu chea fo sidaon.
- Man or Mere wea waka blong olketa fo tanem toktok blong u, babae stap tu, fo mek sua u save an minim gud everi kwesten olketa askem iu.
- Fastaem Prosecutor babae askem iu samfala kwesten. Bihaen diswan babae iu mas talem aot stori blo iu.
- Iu mas ansam nomoa olketa kwesten wea layer blo u askem iu.
- Sapos iu no save minim gud lo kwesten, hem olraet nomoa, bikos iu save talem man or woman stori blo iu fo olketa askem moa disfala kwesten.
- Oketa kwesten ia Lawyer blo accused man bae askem kam lo iu.
- Judge tu babae save askem iu samfala kwesten.
- So iu mas lisin gudfala lo kwesten an ansa long barava tru wei fo talem aot wanem nao iu save herem an lukim for wat happen.
- Iu no ges karange long ansa blong iu o talem kot wanem narafala man or woman I talem iu.

- Sapos iu save tru ansa long kwesten hem olraet iu save se “Ya” or “Nomoa”.
- Sapos iu no save tingim hem olraet nomoa, iu save se “Mi no save tingim nao”.
- Sapos iu no save long ansa hem olraet iu save talem “Mi no save”.
- Bat iu mas tingim gudfala bikos stori blong iu nao Kot hemi laik for herem.
- Iu mas tok klia an tok slou insaet long maekrofon mekem everi wan insaet Kot save herem ansa blo iu.
- Iu no sem sapos iu no save o minim gudfala eni kwesten bikos oketa save ripitim o talem kam fo iu moa.
- Iu no sem or wari tu sapos man or mere wea askem kwesten ia hem luluk tumas or toktok stron kam long iu, iu gohet wetem stori blong iu.

Taem iu kam lo cot fo givim stori lo wat iu sa ve an lukim abautim keis, bae oketa askem iu fo mekem promis lo bible dat bae iu talem tru toktok. Bae iu tekem bible lo raet han blo iu, den cot clak bae talem iu fo tok folom hem. Afta iu mekem promis blo iu, bae iu go sit daun insaed witness box den bae oketa lawyer stat askem iu kwestens an bae iu givin ansas blo iu.

Man fo tanem toktok lo Cot

Sapos iu no sa ve tok English, bae wanfala man hem stap fo tanem raun toktok blo iu from English go lo pidgin. If iu no sa ve tok pidgin, bae wanfala man stap fo tanem toktok blo iu, from pidgin go lo langus blo iu.

Man fo helpem Oketa Disabol fo tok lo Cot

If iu no sa ve toktok or iu earpas, bae wanfala man hem stap fo tanem toktok blo iu lo saen langus. Disfala man bae hem tanem toktok blo cot kam lo iu, lo saen langus wea iu andastanim.

Hao fo helpem oketa Disabol fo kam lo Cot

If iu no sa ve wakabout gud, or iu usim wheel chair, bae cot hem mek sua dat bae oketa mekem iu sit daun gud lo wheel chair blo iu insaed Cot. Bae wheel chair blo iu hem stap lo ples wea Cot save lukim an herem iu gud taem iu givim stori blo iu.

Sapot fo oketa victims an witnesses

Sapos iu wanfala victim or witness blo wanfala crime, bae Ofis blo Director blo Public Prosecutions bae helpem iu fo kam lo Cot.

Sapot ia bae hem stat taem Polis kam servim summons lo iu. Ofis blo DPP nao bae peim ples fo u stap, givim lelbet selen fo peim kakai blo iu, an peim fare blo iu fo go lo Province wea Cot hem herem keis blo u.
